## Question: 1

Calculate the employee turnover rate given a staff of 52 employees when 18 leave the organization.

- A. 34.6 %
- B. 28.8%
- C. 25.2 %
- D. 18 %

**Answer: A**

Explanation:

The employee turnover rate is 34.6%. The calculation is as follows:

$$\frac{\text{Number of employees who left or were terminated}}{\text{total number of employees in department}} \times 100$$

$$\frac{18}{52} \times 100 = 34.6\%$$

## Question: 2

What mineral works in conjunction with calcium to help build strong bones?

**Answer: D**

Explanation:

Energy' requirements do not increase during the first trimester of pregnancy. During the second trimester an estimated 340 kcals per day are needed, and during the third trimester a woman needs an additional 452 kcals per day.

### Question: 4

Which of the following represents the type of production system where food is prepared at one site and transported to another site for serving?

- A. Conventional
- B. Commissary
- C. Ready prepared
- D. Transferral

**Answer: B**

Explanation:

Commissary production is where there is a central location for preparation, and the prepared foods are moved to different sites for serving. This setup is often used to avoid the cost of having multiple sites for food prep, thus commissary production can result in cost containment.

### Question: 5

Which process is most affected in individuals with type I diabetes?

- A. Glycogenesis
- B. Glycolysis

- D. Lactic acid cycle

**Answer: A**

Explanation:

Glycogenesis is impacted the most in type 1 diabetics because insulin, which stimulates glucokinase, is not readily available. Therefore, glucokinase levels are not sufficient; glucokinase is instrumental in the liver's metabolism of glucose.

### Question: 6

Which of the follow does NOT occur when oils are hydrogenated?

**Answer: D**

Explanation:

The creation of more cis formations does not occur when oils are hydrogenated. When oils are hydrogenated, more molecular trans formations are created, not molecular cis formations. Additionally, the melting point is increased, fat becomes more saturated, and the shelf life of the product is increased.

### Question: 7

A registered dietitian has decided to purchase sliced vegetables rather than whole vegetables for their restaurant. Which of the following parameters will be most affected?

**Answer: A**

Explanation:

Labor time will change the most if choosing to purchase sliced vegetables rather than whole vegetables. Vegetables that are already sliced save the labor time which would have been spent slicing whole vegetables.

A dietitian discovers that their client is having trouble meeting the weight loss goals set during their last counseling session. What should the dietitian do?

**Answer: B**

Explanation:

Explanation:
